### 2. General

The Toshiba TLP2361 consists of a high-output GaAlAs light-emitting diode coupled with integrated high gain, high-speed photodetectors. It is housed in the SO6 package.

This photocoupler guarantees operation at up to 125 °C and on supplies from 2.7 V to 5.5 V. Since TLP2361 has guaranteed 1 mA low supply current ( $I_{CCL}/I_{CCH}$ ), and 1.6 mA ( $T_a = 125$  °C) low threshold input current( $I_{FHL}$ ), it contributes to energy saving of devices. It can drive directly from a microcomputer for a low input current.

The TLP2361 has an internal Faraday shield that provides a guaranteed common-mode transient immunity of  $\pm 20~kV/\mu s.$








Fig. 12.1.1 V<sub>OL</sub> Test Circuit




Fig. 12.1.3 I<sub>CCL</sub> Test Circuit




Fig. 12.1.2 V<sub>OH</sub> Test Circuit






Fig. 12.1.4 I<sub>CCH</sub> Test Circuit










### 13. Soldering and Storage

### 13.1. Precautions for Soldering

The soldering temperature should be controlled as closely as possible to the conditions shown below, irrespective of whether a soldering iron or a reflow soldering method is used.






Fig. 13.1.1 An Example of a Temperature Profile When Sn-Pb Eutectic Solder Is Used

When using soldering reflow (See Fig. 13.1.1 and 13.1.2)

Reflow soldering must be performed once or twice.

The mounting should be completed with the interval from the first to the last mountings being 2 weeks.

Mounting condition of 260 °C within 10 seconds is recommended.


- Flow soldering must be performed once.
- When using soldering Iron (Applicable to both eutectic solder and Lead(Pb)-Free solder) Complete soldering within 10 seconds for lead temperature not exceeding 260 °C or within 3 seconds not exceeding 350 °C

Heating by soldering iron must be done only once per lead.


### 13.2. Precautions for General Storage

- Avoid storage locations where devices may be exposed to moisture or direct sunlight.
- Follow the precautions printed on the packing label of the device for transportation and storage.
- Keep the storage location temperature and humidity within a range of 5 °C to 35 °C and 45 % to 75 %, respectively.
- Do not store the products in locations with poisonous gases (especially corrosive gases) or in dusty conditions.
- Store the products in locations with minimal temperature fluctuations. Rapid temperature changes during storage can cause condensation, resulting in lead oxidation or corrosion, which will deteriorate the solderability of the leads.
- When restoring devices after removal from their packing, use anti-static containers.
- Do not allow loads to be applied directly to devices while they are in storage.
- If devices have been stored for more than two years under normal storage conditions, it is recommended that you check the leads for ease of soldering prior to use.






Fig. 16.3 Marking Example (Note)


### Fig. 16.4 Measurement Procedure




